81st Annual Members' Meeting Achieves Success!



On Friday, October 4th, over 200 attendees gathered at Madison Central School for our 81st Meeting of the Members. The evening featured a delicious meal from Brooks' House of BBQ, complemented by live entertainment from the popular Nelson Brothers Band.

CEO Brian Bell, along with the Board of Directors, took the stage to discuss a range of topics, highlighting themes such as growth, success, and Cooperative Principles like Concern for the Community and Cooperation Among Cooperatives.

Mr. Bell began by honoring Mr. Tom Stone for his remarkable 29 years of dedicated service on the Board before his resignation last year. Present in the audience, Mr. Stone received a heartfelt round of applause. Mr. Bell then touched on several key initiatives, including the youth scholarship (details on page 5 for the 2025 application), updates on OMEC's Breast Cancer Awareness Fundraiser (see page 2 for results), the accomplishments of our line crew during this year's storm restoration efforts, and significant Board achievements like completing a Cost of Service study, establishing a 10-year financial plan, proposing a new headquarters, and retiring over \$160,000 in capital credits.

President Rudy Brouillette, re-elected for another three-year term, highlighted Operation Round Up in his address. This voluntary program rounds up members' bills to the nearest dollar, with the collected change supporting charitable causes selected by members at next year's annual *continued on page 3....*

## How to Recycle CFL Bulbs

Compact Fluorescent Lamp or CFL bulbs, while energy efficient, are hard to dispose of because they need to be recycled separately from other materials due to their mercury content. However, we've done the research for you on where to dispose of your old CFL bulbs so you don't have to!

Firstly, lets be clear that no recycling center will take broken or cracked CFL bulbs, so be sure that the bulbs are fully in tact (remember- mercury!). If you are an *Oneida County* resident you can dispose of your old bulbs at the Sherrill DPW Garage located at 210 Elmwood Pl, Sherrill, NY on Fridays from 3pm -5:30pm or Saturdays from 8am-1pm. For more information you can call 315-733-1224.

For Madison County residents (or anyone), you can go to Lowe's at 1200 Lowes Dr, Oneida, NY where you can also recycle #2 & #4 plastic bags, as well as a variety of non-automotive, nonone time use batteries. For hours and more information, please call 315-366-3100.



### Oneida-Madison Electric and Five Other Cooperatives Win \$27 Million Dollar Federal Grant From Department of Energy

Oneida-Madison Electric Cooperative is excited to announce its involvement as a subrecipient in a \$27 million grant from the Department of Energy's Grid Resilience and Innovation Partnerships (GRIP) program. Spearheaded by Delaware County Electric Cooperative, OMEC, along with Otsego Electric Cooperative, and Steuben Rural Electric Cooperative, all from New York, as well as Sussex Rural Electric Cooperative of New Jersey and Claverack Rural Electric Cooperative of Pennsylvania will receive these



federal funds for strategic grid hardening, advanced technology and smart grid deployment, and extreme weather and invasive species resilience.

OMEC CEO and General Manager, Brian Bell, said, "Oneida-Madison Electric Cooperative is excited to partner with our fellow cooperatives in this collaborative effort to strengthen our infrastructures. The Resilience to Intense Storm and Invasive Species-Triggered (RESIST) Grid Disruptions project reflects our shared dedication to ensuring reliable energy for the members we serve."

GRIP is funded through the Bipartisan Infrastructure Law that was enacted in 2021. NYS Senator, Kirsten Gillibrand, was an avid supporter of the cooperatives' application to the Department of Energy, writing in support of the project to the Secretary of Energy, Jennifer Granholm:

"The six electric cooperatives' proposed project will deliver much-needed upgrades to rural electric grids in three states and enable load growth that the region's aging electric infrastructure has otherwise constrained." The grant will be administered over a period of five years to the cooperatives as they plan, procure, and work together to increase the durability of the electrical grid, hoping to improve major outages caused by extreme weather and invasive species by up to 50%.

# ELIGIBILITY CRITERIA

- Have at least a "B" average or better.
- Participate in extra-curricular activities and community service.
- Be available to travel to Washington, D.C. April 27-May 1, 2025 (dates are approximate)



# APPLICATION PROCESS

Interested students should:

- Complete and submit the application by February 3, 2025. Applications available on our website or in our office
- Submit a one-page student essay describing yourself. Essay should include where you go to school, favorite subjects, extracurricular activities, and community service you have been involved in.
- Written recommendations from two references. References must be from a teacher, an extracurricular activity coach or leader, an elected official, religious leader or employer.
- Once applications are submitted an interview will be scheduled.

### **Rising Material Costs: A Path Forward with Resilience and Determination**


Below is a graphic showing the rising costs of materials since January 2020. While it's easy to become frustrated—perhaps even angry—and seek out someone to blame, that's not the approach we're taking.

Instead, we're focusing on what we can control: continuing to work hard. We are actively pursuing additional state and federal grants, advocating in Albany and Washington, D.C. with our elected leaders across party lines, and investing in system upgrades to make our infrastructure more efficient, resilient, and reliable.

As Shakespeare wrote in *A Midsummer Night's Dream*, "Though she be but little, she is fierce." To me, this perfectly captures the spirit of OMEC.

When investor-owned utilities refused to serve the rural homes and farms in our region, our predecessors didn't give up. They came together—combining their heads, hands, and hearts—to form the Cooperative we are today. It was their vision and tenacity that brought electricity to communities that would have otherwise been left behind.

We must remember who we are: a community, a cooperative, a family. Our mission remains clear—to provide affordable, reliable electricity to everyone in our service territory with the resources we have.



Yes, we may be one of the smallest cooperatives in the nation, and the smallest in New York State, but that only fuels our determination. Our size does not limit our potential. It's what we *do* with what we have that matters.

### At Home With Hazel

This traditional gingerbread cake recipe is shown with a decadent butterscotch sauce and a dollop of whipped cream, but can be topped with a layer of cream cheese frosting or served simply with a sprinkle of powdered sugar.

# **Gingerbread Cake with Butterscotch Sauce**

#### <u>Ingredients</u> Gingerbread Cake

2 ¼ cup all-purpose flour
2 teaspoons ground ginger
1 ½ teaspoons cinnamon
½ teaspoon nutmeg
¼ teaspoon ground cloves
1 ½ teaspoons baking soda
¼ teaspoon salt

### **Butterscotch Sauce**

<sup>1</sup>/<sub>3</sub> cup unsalted butter<sup>3</sup>/<sub>4</sub> cup brown sugar<sup>1</sup>/<sub>2</sub> teaspoon salt

<sup>3</sup>/<sub>4</sub> cup unsalted butter, melted
1 cup brown sugar
1 cup molasses\*
1 cup warm water
2 large eggs
2 teaspoons vanilla extract

2/3 cup whipping cream 2 teaspoons vanilla extract



### **Instructions**

### **Gingerbread Cake**

1. Preheat the oven to 350° Lightly grease a 9x13 cake pan and sprinkle with flour.

**2.** In a large bowl whisk together the flour, ginger, cinnamon, nutmeg, cloves, baking soda and salt. **3.** In a separate large bowl whisk together the melted butter, brown sugar, molasses and warm

water. Whisk the mixture enough so that the butter doesn't look separate.

**4.** Whisk in the eggs and vanilla extract. Ensure that the mixture isn't hot before adding in the eggs, otherwise they may scramble.

**5.** Gently whisk the dry ingredients into the wet ingredients until there are no more lumps. The batter will be thin.

**6.** Pour the batter into the prepared pan and bake for 30-35 minutes, or until an inserted toothpick comes out clean or with a few crumbs.

### **Butterscotch Sauce**

**1.** Add the butter to a medium saucepan over low-medium heat.

2. Melt the butter, then once melted add in the brown sugar and salt.

**3.** Gently stir the mixture until the brown sugar is dissolved.

**4.** Bring the mixture to a gentle boil, then whisk in the heavy cream. Whisk the mixture as it gently boils until the cream is incorporated.

**5.** Remove from the heat and whisk in the vanilla extract.

Let cake cool, then slice and serve drizzled with warm butterscotch sauce and a dollop of whipped cream and a sprinkle of cinnamon.

\*use fancy or cooking molasses, not blackstrap molasses. Honey may also be substituted for a milder flavor.
